BENCHMARKING MACHINE LEARNING TECHNIQUES FOR SOFTWARE DEFECT DETECTION

ABSTRACT

Machine Learning approaches are good in solving problems that have less information. In most cases, the software domain problems characterize as a process of learning that depend on the various circumstances and changes accordingly. A predictive model is constructed by using machine learning approaches and classified them into defective and non-defective modules. Machine learning techniques help developers to retrieve useful information after the classification and enable them to analyse data from different perspectives. Machine learning techniques are proven to be useful in terms of software bug prediction. This study used public available data sets of software modules and provides comparative performance analysis of different machine learning techniques for software bug prediction. Results showed most of the machine learning methods performed well on software bug datasets.

How do Agile Software Startups deal with uncertainties by Covid-19 pandemic?

ABSTRACT

The dissipation of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) has already taken on pandemic proportions, affecting over 100 countries in a couple of weeks. The evolution of the disease and its economic impact is highly uncertain, which brings challenges for newly created software companies. Software startups are companies that create innovative software products and services in a dynamic and fast-growing market. Agile Software Methods aims to enable startups in responding to uncertainty caused by Covid-19. This paper investigates the impact of Covid-19 in a real software startup context to understand how they have reacted against uncertainties caused by Covid-19. As a research methodology, action research within Di2Win, a Brazilian software startup, has been applied. The study was carried out throughout six sprints, during the quarantine. Practices employed to mitigate threats while simultaneously allowing teams to remain open to opportunities and challenges are detailed. This paper shares lessons learned that could help agile software startups improve their way of work in an uncertain environment caused by the Covid-19 pandemic.

ABSTRACT

This paper aims to develop e-learning contents for multimedia technology lesson with the purpose to assist students in learning the subject. The multimedia game was used to make the lesson more interesting and at the same time to provide students with real example of how multimedia works. The effectiveness of the developed contents was studied by comparing results of the same test from students taking conventional class-room lectures and those using the developed e-learning contents. We found that the latter performed better at the statistical significance level of 0.05.

AN ANALYSIS OF SOFTWARE REQUIREMENTS SPECIFICATION CHARACTERISTICS IN REGULATED ENVIRONMENTS

ABSTRACT

Requirements Engineering is the set of activities involved in creation, managing, documenting, and maintaining a requirements' set for a product. Engineering involves the use of systematic repeatability techniques to ensure that the Software Requirements are complete, consistent, valid, and verifiable. Software Requirements Specification is an organized process oriented toward defining, documenting and maintaining requirements throughout the development life cycle. Many authors suggest that requirements should always focus their claims on what the software product needs to address, without specifying how to implement them. However, the detail of Software Requirements is influenced by several factors such as: organizational thinking; existing specification standards; and regulatory needs. This work fits exactly with regulatory needs, where the characteristics of Software Requirements Specification in Regulated Environments such as aeronautics, railways and medical are presented and explored. This paper presents and analysis of software requirements specification characteristics in regulated environments. The four characteristics identified are: consistency (internal and external), unambiguity, verifiability, and traceability. The paper also describes the three standards used in these regulated environments (RTCA DO-178C, IEC 62279 and IEC 62304) and examines their similarities and differences from a Requirements Specification standpoint. The similarities and differences will be used to address a future requirements framework universal process that can be configured to address each standard by the usage of Software Process Lines.

CONTRIBUTORS PREFERENCE IN OPEN SOURCE SOFTWARE USABILITY: AN EMPIRICAL STUDY

ABSTRACT

The fact that the number of users of open source software (OSS) is practically un-limited and that ultimately the software quality is determined by end user's experience, makes the usability an even more critical quality attribute than it is for proprietary software. With the sharp increase in use of open source projects by both individuals and organizations, the level of usability and related issues must be addressed more seriously. The research model of this empirical investigation studies and establishes the relationship between the key usability factors from contributors' perspective and OSS usability. A data set of 78 OSS contributors that includes architects, designers, developers, testers and users from 22 open source projects of varied size has been used to study the research model. The results of this study provide empirical evidence by indicating that the highlighted key factors play a significant role in improving OSS usability.
